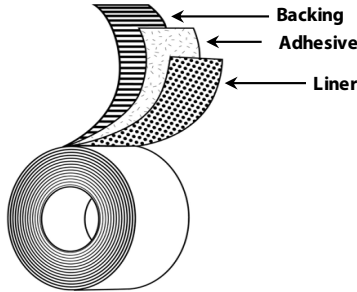


**Non-Woven Single-Coated Tape**
