

Attachment Solutions for Partitioning

You want customers and employees to stay as safe as possible, but certain areas such as checkout registers don't work well at a social distance.

When you're adding partitions to help provide a closer form of separation, consider our reclosable fastener options such as 3M™ Dual Lock™ Reclosable Fastener SJ3550 and SJ3560.

The mushroom shaped interlocking heads provide up to 5x the strength of typical hook-and-loop tape yet are still separable if you need to replace a partition or remove it for cleaning. When it's time to put them together, you can feel the mated sides snap together. The strips and interlocking heads are resistant to most disinfectants and sterilizing cleaners without affecting holding strength.
