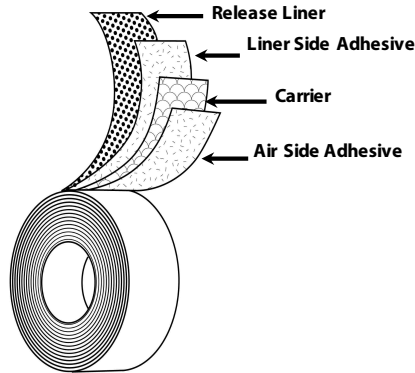


Double-Coated Closed Cell Foam Tape
